

Tampa Bay Rowdies Halfway to Gasparilla Giveaway Sweepstakes OFFICIAL RULES

1. **NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
2. **Eligibility.** Subject to the additional restrictions below, the Tampa Bay Rowdies Halfway to Gasparilla Giveaway Sweepstakes (the "Sweepstakes") is open only to legal residents of the United States (including its commonwealths, territories, and possessions) (the "Eligible Territory"), excluding residents of New York, who are eighteen (18) years of age (except in the case of residents of jurisdictions where the legal age of majority is greater than eighteen (18) years, such legal age of majority) or older at the time of entry. Employees of Rowdies Soccer, LLC ("Sponsor"), Rays Baseball Club, LLC, Union Home Mortgage Corp., and each of their respective affiliated companies, subsidiaries, and advertising and promotional agencies, and the family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win.
3. **How to Enter.** The Sweepstakes will begin on July 13, 2026 at 12:01 am. Eastern Daylight Time ("EDT") and end on August 1, 2026, at 11:59 p.m. EDT (the "Sweepstakes Period").

1. Ticket Purchase Entry Method: During the Sweepstakes Period, eligible participants who purchase four (4) tickets to the Tampa Bay Rowdies match on August 1, 2026 will automatically receive one (1) entry into the Sweepstakes. Tickets must be purchased through an authorized Tampa Bay Rowdies ticketing channel. Limit one (1) entry per person.

2. Mail-In Entry Method (No Purchase Necessary): To enter without purchase, send a 3" x 5" card or piece of paper hand-printed with your complete name, address (no P.O. Boxes), city, state, zip code, birth date, email address, and daytime and evening phone numbers (with area code) in a self-addressed stamped envelope to: Tampa Bay Rowdies, 230 1st Street SE, St. Petersburg, Florida 33701, Attention: Tampa Bay Rowdies Halfway to Gasparilla Giveaway Sweepstakes. Entries must be received by August 1, 2026.

Each mail-in request must be mailed separately and must be original and handwritten. No mechanically reproduced, computer-generated, or photocopied requests will be accepted. Sponsor is not responsible for lost, late, misdirected, illegible, incomplete, damaged, mutilated, or postage-due mail. Limit one (1) mail-in entry per person.

Purchase is not required to enter or win. A purchase will not increase an entrant's odds of winning.

Limit: One (1) entry per person.

By entering the Sweepstakes, you agree to be bound by the Sponsor's Privacy Policy <https://www.uslsoccer.com/usl-privacy-policy> hereby incorporated herein by reference.

Failure to complete any of the steps in this section may result in the disqualification of your attempted entry as determined in Sponsor's sole discretion. Sponsor is not responsible for any issue that may prevent a participant from being able to access the website or complete his/her entry. Entries submitted in compliance with the foregoing and all other terms in these Official Rules are hereafter "Entries" or, individually, an "Entry."

Any winning contestant must be the same person who originally entered to participate in the Sweepstakes. No family members, friends, office associates, or any other person will be allowed to

participate in a Sweepstakes on another person's behalf. A contestant must provide his or her own name as listed on his or her valid Florida driver's license or Florida state-issued ID (or other proof of Florida residency, such as a copy of a utility bill). If a participant uses a false name on any ID submitted as proof of identification, he or she will be immediately disqualified from the Sweepstakes and be ineligible to win any prize.

The winner must be one (1) of the people attending the Events and the other permitted guest will be of the winner's choosing, subject to the terms of these Official Rules. If Winner elects to partake in any or all portions of his/her Prize with fewer than the allotted number of Guests or no Guests, the Prize will be awarded to Winner and each participating Guest and any remainder of the Prize will be forfeited and shall not be subject to further or alternative compensation.
